Office Highlights

IIBA has grown and evolved into the largest nonprofit provider of immigration legal services in Northern California. From a single office in 1918, IIBA now has teams in San Francisco, Oakland, Redwood City, Brentwood, Fremont, Napa, and Petaluma, working tirelessly to advance rights and opportunities for immigrants in our communities. Below are some 2022 highlights from each of our 7 offices:

Napa

This past year, IIBA provided more than 1,000 legal consultations and filed nearly 700 immigration cases on behalf of clients in the Napa community.

Petaluma

IIBA opened a new office in Petaluma, after having a presence in Sonoma County since 2017. We partnered with the Center for Domestic Peace to provide immigration clinics and legal support to survivors of domestic violence and sexual assault.

Oakland

San Francisco

The San Francisco Pathways to Citizenship Initiative has helped more than **10,600 individuals** become U.S. citizens since 2013. IIBA joined local government and community partners in large-scale in-person naturalization workshops for the first time since Covid.

Redwood City

For the first time in 48 years of serving immigrant families in San Mateo County, IIBA has its own office in the heart of downtown Redwood City. We celebrated this milestone with our community at a festive ribbon-cutting ceremony in December.

Fremont

IIBA served a critical role in local community efforts to support new arrivals from Afghanistan, helping Afghan families file applications for asylum and U.S. residency, and connecting our clients with other essential services as they adapt to their new home.

Brentwood

IIBA celebrated 10 years since the opening of our Brentwood office. We continued to partner with Stand Together Contra Costa, which is a multiagency initiative supporting immigrant families through a rapid response hotline, legal services, and community education.

Removing Financial Barriers to Immigration

In December 2021, IIBA was selected by the California Department of Social Services (CDSS) to convene 9 partner organizations and offer filing fee assistance to eligible clients applying for naturalization or DACA.

IIBA went beyond our role as a legal service provider to advocate for and provide much-needed financial relief to low-income immigrants in the community. In the first year of the program, we administered **345 checks to cover naturalization application fees (\$725) and 1,469 checks to cover DACA application fees (\$495)**. These funds make it possible for low income immigrant families to apply for the legal

Higher Education Legal Services Project

The California Community Colleges is the largest system of higher education in the country with the largest population of undocumented students.

IIBA has been a trusted presence on 5 community college campuses in the Bay Area, providing free immigration legal services and educational outreach to students, faculty, and staff. Since the start of the Higher Education Legal Services Project in November 2019, IIBA has delivered **1,629 legal services**, from comprehensive screenings to asylum applications.

COMMUNITY COLLEGE STUDENT SPOTLIGHT

Siwei moved from China to the U.S. in 2015 to pursue her educational goals in computational linguistics. As an international student at City College San Francisco (CCSF), Siwei was involved with the Associated Student Council and helped connect fellow students with helpful information and resources, like IIBA's free immigration legal services.

When it came time for Siwei to adjust her status after getting married, she knew exactly where to go for reliable legal services. With IIBA's support, Siwei was able to secure permanent residency to stay with her husband in the U.S.

"After receiving my green card, I have felt more connected with this country that I'm living in," said Siwei. "I can finally focus on making future plans and reaching career goals."

Extending Our Reach

PRO BONO PROGRAM

In 2022, IIBA grew our Pro Bono Network to meet the growing demand for high-quality, individualized legal assistance. We partnered with law firms and corporations to host 25 immigration clinics, training and matching volunteers with 416 clients to help them apply for citizenship or renew their DACA status.

IIBA's law firm and corporate partnerships have made it possible to serve more clients remotely and expand our reach to 25 counties beyond IIBA's brick-and-mortar offices. As a result, clients are able to conveniently and safely access the legal support they need, no matter where they are.

Opening Doors



"Even though I don't know it, I was so happy to show my daughter where I was born, where I lived." — Zayra

Despite calling the United
States home for the majority
of her life, Zayra never felt like
she truly belonged. Her parents
had brought her to California
at a young age, in hopes of
giving their daughter a better
life than Mexico could give.

Growing up undocumented in the Bay Area, Zayra learned that many doors were closed to her simply because of her immigration status. When she was in high school, the Deferred Action for Childhood Arrivals (DACA) program opened up, allowing Zayra and over 800,000 young immigrants to work legally and be protected from deportation. DACA helped Zayra go to college and pursue opportunities working with youth at the high school she once attended.

Still, DACA's limitations and the persistent attacks on the policy over the years meant that Zayra was forced to live in a constant state of

limbo, fearing that the protections could be taken away at any moment. When Zayra suffered from domestic violence in her marriage, the need for security beyond her two-year DACA status became even more critical.

Zayra turned to IIBA for legal support. As a survivor of abuse, Zayra is eligible for protections under the Violence Against Women Act (VAWA), which helps immigrant survivors escape violence and build safe, independent lives through a pathway to residency.

"IIBA made me feel like I wasn't alone in the process," said Zayra, who petitioned for legal status through VAWA. "I only paid immigration fees, but other than that everything was covered. It was such a great help because I was going through it all at the time – a divorce, raising my daughter, everything."

After more than 3 years of anxiously waiting, Zayra secured

her permanent residency in February 2022. Hearing the news, she felt a rush of emotions and dropped to her knees in tears, knowing what the green card meant for her and her family.

"Now that I'm a resident, I belong now," said Zayra. "I can actually follow my dreams and not have to worry about what would happen if DACA ends or if I'm taken away from my daughter."

Doors that were once shut are now open to Zayra. That summer, Zayra took her daughter on a trip to Arteaga, Mexico, a place she had not been able to return to for over 20 years. There, Zayra had the chance to reunite with her grandparents and beloved uncle, as well as show her daughter her birthplace. The trip was "the best experience ever."

Now, Zayra can focus on bigger goals: buying a home, building a stable future for her daughter, helping her mother become a resident, and working towards her dream job as a probation officer or district attorney. She also plans to pursue U.S. citizenship as soon as she becomes eligible.

"I won't be stopped anymore for my immigration status," Zayra said confidently.

Fostering Civic Engagement

In California, there are approximately 1.6 million permanent residents who are eligible to naturalize.

Unfortunately, the complex legal process, high application fees, and mandatory civics and English tests have deterred many immigrants from taking the steps to become U.S. citizens.

To address these barriers, IIBA offers not only legal services and

fee assistance, but also free group classes and one-on-one interview practice. 98 percent of our students who apply for citizenship pass. In 2022, we supported 178 students in preparing for their naturalization interviews and tests, totaling more than 410 hours of in-person and online programming. These accomplishments are a testament to the strong partnership between IIBA and our community of volunteers.

Getting Out the Vote

IIBA joined the nationwide effort to increase voter turnout in the 2022 primary and general midterm elections, organizing 82 volunteers to help naturalized clients and community members understand and exercise their right to vote. "Immigration has been a part of my entire life experience. I come from two parents who are immigrants, one of whom was undocumented. In their sacrifices and in coming here, they were able to provide me with the opportunity to get an education and to work. I really believe in the work IIBA is doing to provide accessible legal services to folks who need it so that everybody has the opportunity to stay in this country."

Now that I understand how much of a true privilege and blessing it is to be a citizen and how much some people are struggling to try to get to that point, how can I leverage that privilege and blessing to do good for others? It's made me reflect on my position in the world and what I can do to make it better."

"I'm an immigrant myself and I come from a family of immigrants. A lot of times there's a sense of fear or isolation within immigrant communities, like there's nobody really there to support us. IIBA's services show that that's not true, that there are people who care and are willing to be there and provide support along the way. Some clients remind me of my family and my parents, so just having that one-on-one connection and mutual understanding is very special. The space that IIBA has created is really sacred to me."




