Dear Friends,

Many years ago, a loyal donor made a personal visit to our main IIBA office, back when we were still on Mission Street in San Francisco.

Raj brought his college-bound son along with him and shared the story of how IIBA made an impact on their lives. It was 1974 when Raj at 18 years old immigrated from India to the United States on a student visa. One day, he was notified that a complication with his visa was jeopardizing his legal status to live and study in the United States.

Fearing deportation, he called everywhere. No one returned his call. He felt helpless.

Then someone suggested he contact IIBA. Our agency was able to walk him through the steps that ultimately allowed him to secure a solution.

"It was the first time anyone showed that they cared about me," he said, handing over a check. "It's because of IIBA that my son now has the opportunity to attend med school." This was the first time he had shared his story with his son and it was a poignant reminder of how even the seemingly smallest of actions can have a lasting impact.

As you read through the pages of this annual report, you'll see similar success stories of how access to IIBA's services changes the trajectory of families for generations.

As we inch closer toward a presidential election, it could be tempting to feel powerless and overwhelmed by a political tsunami of anti-immigration rhetoric inevitably heading our way.

But are we truly powerless? Of course not.

There's a reason why IIBA has been around for more than 100 years. Because together we are powerful. Together, with your support, we will continue to fulfill the IIBA mission long into the future.

Measuring IIBA's Impact in 2023

In 2023, IIBA provided more than

5,646 legal consultations and reached 9,973 immigrants.

Every immigration case is unique. IIBA's team supports clients facing diverse legal needs, including citizenship petitions, DACA applications and renewals, family reunification, humanitarian services, and removal defense. In the past year IIBA helped:

Office Highlights

IIBA opened our doors as the International Institute of San Francisco in 1918, emerging in response to the refugee crisis on the heels of World War I. Today, IIBA is the largest nonprofit provider of immigration legal services in Northern California, with offices in San Francisco, Oakland, Redwood City, Brentwood, Fremont, Napa, and Petaluma. IIBA has grown to nearly 75 staff members who work daily to advance immigrant rights and help immigrants gain greater security.

Napa

In 2023, IIBA provided nearly 1,000 legal consultations and exceeded 700 immigration cases for clients in the Napa community—many from the Ukraine. In collaboration with local partners, the IIBA Napa office organized nearly a dozen in-person citizenship workshops in 2023.



Petaluma

The Petaluma IIBA office received a grant to partner with the Center for Domestic Peace to increase access to justice for survivors of domestic violence in nearby Marin County and continue serving Sonoma County. We also had a staff member become DOJ-accredited.

Oakland

We continue to be a leading service provider for victims of domestic violence and other crimes needing to secure legal status. We renewed our collaboration with the Alameda County District Attorney's Office/Family Justice Center to provide immigration legal consultations to their clients at their facility in Oakland.

Redwood City

The RWC office has been strongly advocating for increased county funding for removal defense, meeting with county officials and collaborating with eight other organizations to submit a proposal. The RWC office also made a major push to benefit from the DNAF bonus legal assistance funding, filing 41 naturalization applications in the last three days of December.

San Francisco

IIBA partnered with city government and other immigration nonprofits to provide free legal services to DREAMers and their families. IIBA and our partners also hosted an in-person clinic at the San Francisco Public Library in October.

Our team moved to a larger office to accommodate a growing staff and demand for IIBA's services in eastern Contra Costa County. We continued our successful partnership with Stand Together Contra Costa.

Fremont

Since opening our Fremont doors in 2013, IIBA has supported over 1,600 Fremont residents from 70 countries with high-quality immigration legal services. A big thanks to the Fremont City Council for recognizing this milestone and IIBA's commitment to serving residents of southern Alameda County.

Removing Financial Barriers



Even when immigrants obtain affordable legal services, steep application fees often remain a significant barrier to changing their immigration status. In 2023, the cost of filing a naturalization application with U.S. Citizenship and Immigration Services was \$725; the fee for applying for DACA was \$495 and must be renewed at the same cost every two years. These filing fees are expected only to increase in coming years. To ensure that these costs do not stand in the way of our clients fulfilling their goals in this country, IIBA offers filing fee assistance to eligible clients applying for naturalization or DACA, thanks to a partnership with California Department of Social Services.

Centering Immigrant Experiences



DREAMSF FELLOW SPOTLIGHT CHRISTINE AGUADO

IIBA partners with the City and County of San Francisco to provide mentorship and support to immigrant students and aspiring professionals through the DreamSF Fellowship program. We were fortunate enough to have been matched with UC Davis alumna Christine Aguado, who is committed to giving voice to immigrant communities through her work in social media and storytelling.

With a strong interest in increasing the representation of immigrant stories in the media, Christine has been gaining valuable skills and experience while serving as IIBA's Communications Fellow. Christine is working towards a career in communications and advocacy for immigrant communities.

Fostering Civic Engagement

In California, there are approximately 1.6 million permanent residents who are eligible to naturalize. Unfortunately, the complex legal process, high application fees, and mandatory civics and English tests have deterred many immigrants from taking the steps to become U.S. citizens.

To address these barriers, IIBA offers not only legal services and fee assistance but also free group classes and one-on-one interview practice. **Ninety-eight percent of our students who apply for citizenship pass**.

In 2023, **58 volunteers supported 243 students in** preparing for their naturalization interviews and tests, totaling more than 525 hours of in-person and online programming.

Getting Out the Vote

Ahead of the March 2024 primary, IIBA reached 1,230 former clients and recently naturalized citizens to assist them with voter registration and education. We hosted four ballot parties and voter information sessions, both online and in-person, and trained 37 volunteers, including high school and college students, and other immigrant and bilingual youth and adults to be outreach ambassadors in support of voter outreach and registration. This work is supported in part through a grant from the Silicon Valley Community Foundation. IIBA will continue reaching out to potential voters via text, phone, and voter education forums before the November 2024 general election.

Uplifting Immigrant Voices



Jacqueline was born in Mexico and came to the United States when she was eight years old. Today she is one of more than half a million people protected by the Deferred Action for Childhood Arrivals (DACA) program, which gives her temporary permission to live and work in the country she's known most of her life. Her own experiences as an immigrant have led her to a career serving others with undocumented status in the community. Until recently she served as the coordinator of City DREAM, a resource center for undocumented students at City College of San Francisco (CCSF), where she connected students to services such as academic counseling, financial aid, and, thanks to a partnership with IIBA, free legal services.

"Trust is key for legal services for the immigrant community," says Jacqueline. She believes IIBA has earned that trust by steadfastly supporting and advocating for so many in the CCSF community. Whenever her students had questions about their immigration options, she encouraged them to meet with the IIBA team.

"I think students are very scared to talk about their immigration status. We're taught that the quieter you are, the safer you are. But **talking to a legal service is as important as going to the doctor.** Laws are always changing, there are new programs, new opportunities, so I try to promote IIBA as much as I can."

Having an ally like IIBA is particularly important for immigrants concerned with their long-term stability in the U.S. While DACA has opened many doors for community members like Jacqueline, the future of the program is uncertain.

"Even though I have DACA, I still consider myself undocumented because my status could be taken at any point. It's not a stable status," Jacqueline says. Knowing this, she advised her students to consult with IIBA to determine if they were eligible for more secure forms of relief, such as permanent residency or citizenship.

Reaching Immigrants in Higher Education

IIBA partners with the **Higher Education** Legal Services Project to provide free immigration legal services and case support for students, staff, and faculty at 5 community colleges around the Bay Area.

Since the start of the Higher Education Legal Services Project in 2019, IIBA has delivered 2,158 legal services, from comprehensive screenings to asylum applications, including 655 legal services in 2023.

That's \$32,600 saved for California community college students in 2023.

As a CCSF staff member, Jacqueline also qualified for assistance from IIBA and became a client herself. She worked with IIBA to renew her DACA status every two years and to apply for advance parole, special permission for DACA recipients to leave and reenter the country.

"I hadn't gone back to Mexico for over 20 years, so this was the only way I could go back and visit my family. It was a big deal for me." It took Jacqueline nearly two years to receive advance parole approval, but IIBA was with her every step of the way, from the initial meeting to discuss her options to double-checking that she had all the documents she needed to return to the U.S. after her trip.

"If I had a question about my family members or someone I know heard something on the news, I would first go to IIBA because I trust them," Jacqueline says. "So it's not just me but a whole community that's also benefiting from IIBA."

Journey to Citizenship sayda and jessica's story

At IIBA, we know the courage, resilience and fortitude it takes to leave one's homeland for an uncertain future. The embodiment of that spirit can clearly be seen in the story of Sayda and Jessica—a mother and daughter—who came to IIBA over a decade ago, when they had nowhere else to turn.

"My mother was a victim of domestic violence," explains Jessica. "No wife, no child—no one person should ever be put through that kind of abuse. I wanted to make sure that my kids would never have to experience that level of violence and trauma in their childhood."

Becky Bogyo, a Senior DOJ Accredited Representative in the IIBA Redwood City Office had reviewed paperwork which showed that Sayda might qualify for a U visa for crime victims.

"I was very surprised when I received a call from Becky telling me that I had the opportunity to fix my legal status and I couldn't believe it," says Sayda, who is from Guerrero, Mexico. "So I told my daughter, 'Let's go, IIBA called me.' But I didn't know what to think. When we arrived at the appointment and we started to fill out paperwork it gave me hope to be legal here in the United States."

After consulting with them, Bogyo determined that Sayda could in fact qualify for the U visa and that her daughter Jessica had her own case and she could also include her husband. IIBA was able to help the whole family.

The process from getting a work permit to becoming a resident to becoming a citizen took over 10 years. From navigating paperwork to understanding legal intricacies, Bogyo empowered Sayda and Jessica every step of the way.

"It's a huge life changer," says Bogyo, "because they've lived for so long in the shadows without being able to just be free and be themselves and live in peace."

Sayda was able to find a job with benefits and fair pay—something she never took for granted. Jessica was able to get a driver's license, which gave her more employment options, leading to stability for her growing family. Her oldest child is now on track to be the first in their family to attend college demonstrating the impact IIBA has on families across generations. Jessica says she can't even imagine what her life would be like if they hadn't made a call to IIBA.

"We were with them as their kids went from preschool through college," says Bogyo. "And now, with citizenship, it's like they've graduated from immigration. You're here now. You made it."

"Working with IIBA is an amazing experience," says Jessica. "I'm always telling everyone about IIBA's services, and how IIBA helped me and my mom and my husband and everybody in my circle of family. Thanks to IIBA, our entire community grows and improves."

Reunited After 16 Years

When Rubiciela's daughter, Libni, became sick as a baby, Rubiciela struggled to pay for medical treatment. She made the difficult decision to leave her family behind in Mexico to seek economic opportunities in the U.S. After years of hard work and sacrifice, Rubiciela obtained a U visa with IIBA's support, giving her a pathway to legal permanent residency. After 16 years of separation, Libni was able to join her mother in the U.S. and has recently become a mother herself. All three generations now live together in San Francisco.

Libni recently received her own U visa work permit. Now she can work lawfully in the U.S. while she waits for her chance to apply for a green card (with IIBA's assistance).

IIBA has expanded our network of pro bono attorneys to meet the growing demand for high-quality, individualized legal assistance.

In 2023, we partnered with law firms and corporations to host **28 virtual immigration clinics**, training nearly **500 attorneys who donated their time and expertise to 450 clients** to help them apply for citizenship or renew their DACA status. The Pro Bono Program provides 100% remote service, ensuring clients are able to conveniently and safely access the legal support they need, no matter where they are.
